John Keleher was excused from this meeting but reported to the Supervisor the following:

- Paving in the town is completed.
- They will pave in the Village of Norwood June 20-21.
- We should hear about the PAVE NY funds by the end of June.

CEO REPORT

• 19 permits were issued in the amount of \$1,186.25.

COURT REPORT

- \$35,855.50 in fines was collected.
- 307 cases were closed.
- 319 new cases were opened.
- The May restitution check from Ms. Guyette was not received, but St. Lawrence County has both May and June, which is being forwarded to the court. Village parking money in the amount of \$101 (CK #10540) was submitted on Judge Charleson's report.
- Councilwoman Rivezzi confirmed that Court Clerk Hayes will give the board a detailed report regarding the consolidation in July.

ASSESSOR'S REPORT

Mr. Snyder reported:

- Eight people contested 10 assessments in person on Grievance Day and 9 grievances were sent by mail. A total of 533 change notices were mailed this year.
- Exemption letters were mailed to everyone who had applied to receive a STAR exemption this year, explaining changes made by New York State and giving them information on how to apply for their STAR rebate checks.
- Final assessment roll is ready for printing and will be ready by July 1st.

RECREATION REPORT

Rose Rivezzi reported that the Rec Committee will be meeting on June 15th. They will be reviewing the local bids they received for repointing the arena. She said bids included classic repointing vs. repointing with the exterior surface to be covered. She reminded everyone about the lawn mower races.

ECONOMIC DEVELOPMENT COMMITTEE

At a recent business symposium, Councilperson Rivezzi, Chamber Director Marylee Ballou and Planning Director Fred Hanss discussed the possibility of forming an Economic Development Committee to be comprised of the Potsdam Chamber Director, the Planning and Development Director, two village board members, two town board members, and two community members. The focus of this committee would be to help facilitate and assist new and existing businesses with their questions regarding loans, helping those in need, and generally help to facilitate and keep businesses strong in the our community. Rivezzi said that she discussed this idea with Mayor Tischler and the Village Board will discuss this in the near future. Supervisor Beattie said that he would wait until the Village makes their decision before moving forward with any appointments. Any board member interested in serving should contact Supervisor Beattie.

POLICY COMMITTEE REPORT

Councilperson Carvill reported that the Sexual Harassment and the Workplace Violence policies had been updated and they are meeting with Attorney Cappello to review. They are now working on the internet usage and procurement policies. Attorney Cappello reminded the board members that once they accept the draft policies, they will need approval from the collective bargaining units. He said that procurement thresholds are set by New York State. Councilperson Rivezzi said they will meet with the employees to discuss the policies and recommended yearly staff meetings as a reminder. The draft policies should be ready for the July meeting.
