A LOCAL LAW ENTITLED AMENDMENT TO ARTICLE III  
SECTION 306-4 ENTITLED ZONING MAP

Be it enacted by the Potsdam Town Board of the Town of Potsdam as follows:

Section 1:

The Potsdam Town Code Article III Section 306-4 entitled "Zoning Map" is hereby amended as follows:

The following parcels are hereby changed to a Residential Agriculture District (RA)

Section 2:

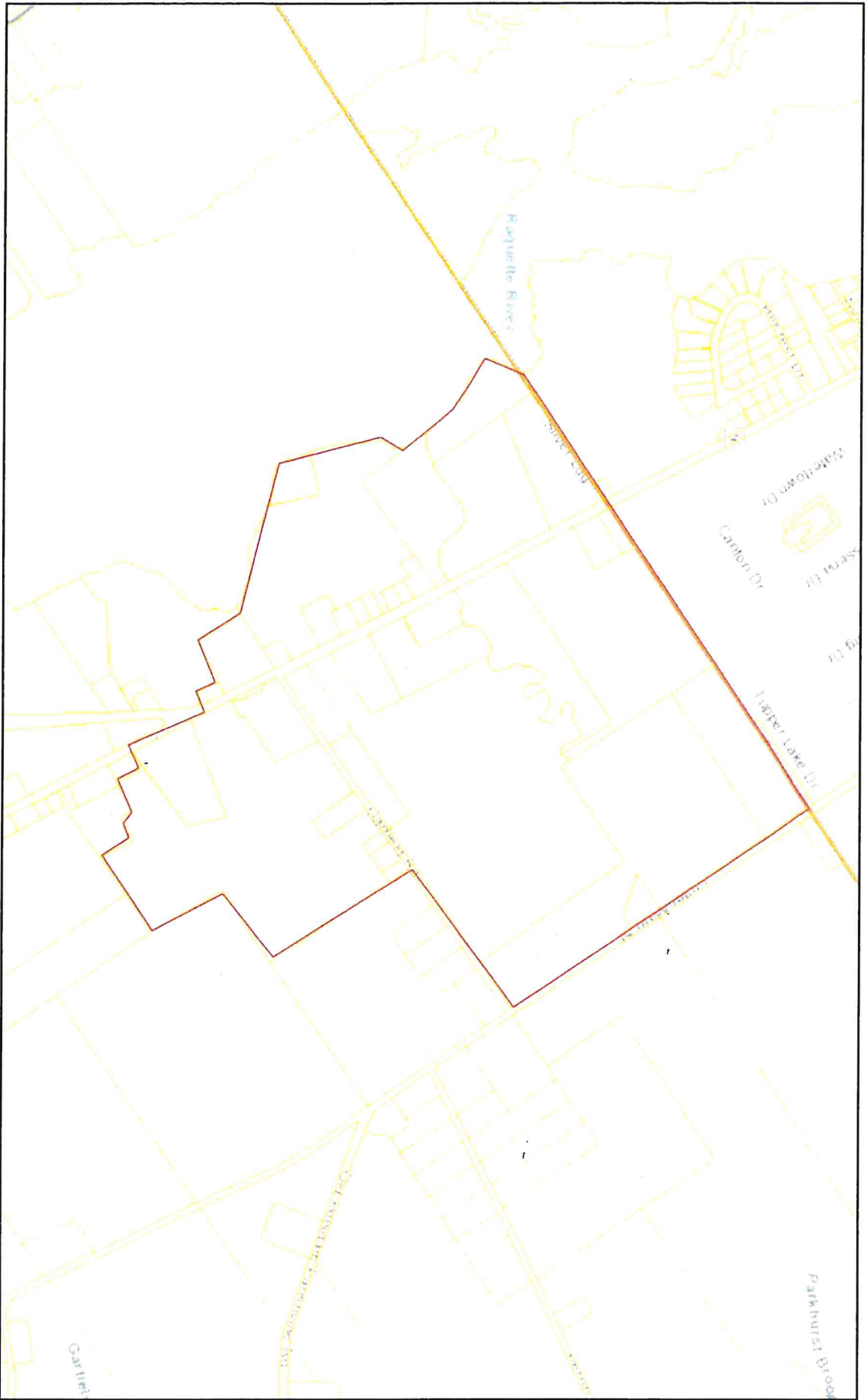
If any part or provision of this Local Law or the application thereof to any person or circumstance be adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the part or provision or application directly involved in the controversy in which such judgment shall have been rendered and shall not affect or impair the validity of the remainder of this Local Law or the application thereof to other persons or circumstances, and the Potsdam Town Board of the Town of Potsdam hereby declares that it would have passed this Local Law or the remainder thereof had such invalid application or invalid provision been apparent.

Section 3:

All Ordinances, Local Laws and parts thereof inconsistent with this Local Law are hereby repealed.

Section 4:

This Local Law shall take effect immediately upon filing in the office of the Secretary of State in accordance with section twenty-seven of the Municipal Home Rule Law.
